KNOW ALL MEN BY THESE PRESENTS:

THAT, RIO HONDO RANCH, INC., hereinafter referred to as Developer, of Kingsland, Llano County, Texas, the owner and developer of RIO HONDO RANCH, a subdivision of Bandera County, Texas, as shown by the map or plat of said subdivision, recorded in the Plat Records of Bandera County, Texas, does hereby make and declare the following restrictive covenants:

1. Septic tanks are required to be used for sewage disposal and any other sewage disposal system such as but not limited to an outside toilet, privy, or cesspool are expressly prohibited.
2. No motor powered boats or other floating vessels shall be operated on any body of water situated within said subdivision.
3. No swine shall be raised, bred, or kept on any tract within said subdivision for commercial purposes.

Invalidation of any one of these covenants or restrictions by judgment or court order shall in no way affect any other provision, and all other provisions shall remain in full force and effect.

The Developer, or any owner, shall have the right to enforce, by any proceeding at law or in equity, all restrictive covenants herein imposed. Failure to enforce any restrictive covenant contained herein shall in no event be deemed a waiver of the right to do so thereafter.

These restrictive covenants shall run with and bind the land and shall inure to the benefit of any owner of any lot subject to these restrictive covenants and their heirs, successors, assigns, and legal representatives.

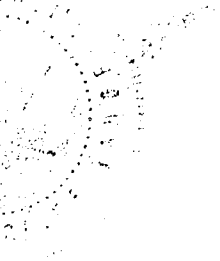
